### General Description

The Benzoin tree grows up to 20 metres high. The leaves are oval and hairy and the flowers are fleshy, greenish-yellow in colour. Deep incisions are made in the trunk of the tree, from which the yellowish coloured sap exudes. When the resinous lump is exposed to light and air it becomes hard and brittle, it turns brownish-red in colour and it is collected from the bark.

### Extraction

Styrax Benzoin Extract is an extract of the balsamic resin of the Benzoin, Styrax benzoin, Styracaceae and is prepared from the benzoin crude using solvents. It is diluted with Dipropylene Glycol to make it more pourable and easier to handle.
