Chamomile is a small, perennial herb, belonging to the Asteraceae family. Growing up to 25 centimetres high, it has white flowers and feathery leaves.

Extraction

Anthemis nobilis Flower Oil is the volatile obtained by steam distillation from the dried flowering heads of *Anthemis nobilis*.

- Fragrance component in soaps, detergents and cosmetic products.
