Bergamot is a small tree belonging to the Rutaceae family. Growing up to 4.5 metres high, it has oval leaves and green fruit that ripens to yellow.

Extraction

Citrus aurantium bergamia Fruit Oil is obtained by pressing the peels of the unripe fruits of *Citrus bergamia*.
