Geranium is a perennial, hairy shrub belonging to the Geraniaceae family. Growing up to 1 metre high, it has small, pink flowers with pointed, serrated green leaves.

### **Extraction**

Pelargonium graveolens Flower Oil is the volatile oil obtained by steam distillation from the flowers of *Pelargonium graveolens*.

### **Common Uses/Applications**

- Aromatherapy applications.
- Fragrance component in soaps, perfumes and cosmetic products.
