### General Description

Palmarosa is an herbaceous plant belonging to the Gramineaceae family. The herb has fragrant leaves and long, slender stems with flowering tops. When growing wild, the long and narrow-lanceolate leaves of this plant may attain 2.5 to 3.0 metres in height, forming rounded clumps measuring up to a metre across.

### Extraction

Cymbopogon Martini Oil is the volatile oil extracted by distillation from the herb palmarosa, Cymbopogon martini, Gramineae.

### Common Uses/Applications

- Aromatherapy applications.
- Fragrance component in perfumes and cosmetic products.
