The oil is widely used to aid damaged, wrinkled skin as it helps balance the moisture levels of the skin, so it is best applied directly to the skin or hair, however alternatively it is just as effective in the right formulation.
Functionality	Wild harvested in Brazil. Known to be an effective skin & hair cell strengthener. Gives the skin firmness & hair shine. Widely used on old & damaged skin & acts as an effective anti-inflammatory ingredient. Rich in antioxidants, phytosterols & a wealthy fatty acid profile.
REACH Status	SoapQueen can confirm that Green Coffee oil - cold pressed supplied is exempt as per Annex IV & V according to EU regulations 1907/2006. This product is not chemically modified, it comes under derogation pursuant to EU regulation 987/2008, Annex II, #9. Hence registration is not required for this product. We can also confirm that none of the substances on the SVHC candidate list can be verified in a concentration of >0.1% in our product.
