The refined version offers you the benefits of Sunflower oil but without the aroma. There are no limits as to what you can use this oil in, body/face/feet, there is not an area of the body this ingredient will not suit. This particular oil is high in Oleic acid. High Oleic means that it is high in monounsaturated fats, one of the main benefits of this is that it is a far more stable oil to that of standard conventional sunflower oil.

REACH Status	SoapQueen can confirm that Sunflower oil High Oleic - refined supplied is exempt as per Annex IV & V according to EU regulations 1907/2006. We can also confirm that none of the substances on the SVHC candidate list can be verified in a concentration of >0.1% in our product.
