General Description

The waters of the Dead Sea are unique, having a total salt concentration that is 10 times higher than ocean water, reaching 33% versus 3%. The composition of the brines is also unique, comprising magnesium, potassium and calcium chlorides, in addition to a high concentration of bromides.
